NOTICE OF VARIATION OF LICENCE NO. 20533

BACKGROUND

- A. ACCIONA INFRASTRUCTURE AUSTRALIA PTY LTD ("the licensee") is the holder of Environment Protection Licence No. 20533 ("the licence") issued under the *Protection of the Environment Operations Act 1997* ("the Act"). The licence authorises the carrying out of activities at PACIFIC HIGHWAY, NAMBUCCA HEADS, NSW, 2448 ("the premises").
- B. On 30-Aug-2018 the Environment Protection Authority (EPA) received an application for the variation of the licence. The application sought to vary the licence in the following manner:
 - Remove an area east of the Warrell Creek to Nambucca Heads Pacific Highway Upgrade project from approximate chainage 53300 to 54500. A development approval (DA) has been granted to NSW health Infrastructure for the construction of a hospital at this location (North Macksville). The hospital site will be subject to a separate Environment Protection Licence. This variation reduces the premise boundary of EPL 20533 to ensure there is no overlap of EPL premises.

A series of revised premise boundary maps were provided (identified as the Pacific Highway Upgrade WC2NH EPL Revision 20) to the EPA, which includes the changes to the premise boundary as detailed above.

- C. The EPA reviewed the change to the premises boundary detailed in the application and considered the matters identified in section 45 of the Act and is satisfied that the variation requested has been approved in accordance with the Environmental Planning and Assessment Act 1979 and can be managed in a manner which will provide an appropriate level of environmental protection.
- D. The EPA has therefore approved the application.

- 2. The following variations have been made to the licence:

 - Condition A2.2 was amended to reflect the current set of approved maps.
